Bookings not guaranteed until payment is received. Sites will be reallocated without further notice if bookings are not fully paid by the above date.

All Trade Displays must ensure that stalls are of show standards with suitable stands and backings. This **MUST** be adhered to in the interests of all Trade Displays and exhibitors. Trade Displays shall not assign or sublet any part of allocated space without the consent in writing to the Trade Display Steward. The site allocated **MUST NOT** be changed without the approval of the Trade Display Steward.

When calculating your trade site space, please ensure you include if you need to have a trailer or similar behind your gazebo into your depth.

The Society reserves the right to unforeseen circumstances to amend or alter the exact site of the location of the stand and the Exhibitor undertakes to agree to the alteration to the site or the space re-allocated by the Society.

**N.B.** Care should be taken in selecting suitable items to sell. The Trade Display Steward shall be given power to enter the area prescribed and remove any article, sign, picture or printed matter, as per the Agricultural Society's list of 'Banned Items'.

Trade Display holders are advised that their stalls must be set up and ready for operation by **8:00am Friday 24<sup>th</sup> and Saturday 25<sup>th</sup> May 2024** of Traders to be there to man their stands by that time. The Showgrounds will be open for pre-setting up purposes from 12pm to 5pm on Thursday 23<sup>rd</sup> May. **Closing time: All stalls holders must trade until 6:00pm on Saturday.** Night entertainment finishes at 7:30pm.

**ONLY ONE VEHICLE AND TWO ATTENDANTS FOR THE TWO DAYS ARE ALLOCATED TO EACH SITE.**

**YOU ARE GIVEN YOUR ALLOCATED TRADE DISPLAY SITE UPON ARRIVAL AND NO CHANGES OR MOVEMENT IS TO BE MADE. YOUR DESIGNATED TRADE DISPLAY SITES ARE FINAL.**

## **IMPORTANT NOTICE TO ALL EXHIBITORS**

Any exhibitor intending to bring electrical equipment to the Showgrounds will be required to ensure that such equipment fitted with **earth leakage circuit breakers** and that all electrical leads, tools, and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow exhibitors and the general public and is a requirement by **Workplace Health and Safety Act of 1989**. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at the Esk Showgrounds. Please check all your electrical equipment and leads before you come, to avoid any difficulties.
