# Camping at the Esk Showground is subject to the following conditions:

- 1. The Esk Show Society permits camping on site subject to the terms expressly set out in this agreement, and all applicable rules, by-laws and regulations of the The Esk Show Society.
- 2. The camper/hirer must pay to the Esk Show Society the relevant hire fee before the commencement of the hire period. Access will not be granted until full payment has been received by the Esk Show Society.
- 3. The Camper/Hirer must adhere to the following obligations:
  - The Camper/hirer must not remove any items such as fixtures and fittings or structures including portable assets.
  - The Camper/hirer shall keep the site in good repair, order and clean condition at all times to the satisfaction of the Esk Show Society.
  - At the termination date or exit date the camper/hirer must at the camper/hirer's cost leave the site in a clean and tidy manner and to the same condition that existed at the commencement of the hire period.

- The Camper / hirer must not cause or contribute to any damage to the site or showgrounds generally. Such damage must be made good at the camper/hirer's expense and to the satisfaction of the Esk Show Society.
- The Camper/hirer shall not allow disconnection of or disruption to any utility or other services or alteration of or disruption to existing improvements with respect to the site, without the Society's prior approval.
- The camper/hirer must use any property, goods, materials, services or information provided by the Esk Show Society at or on the site:
  - i) At its own risk
  - ii) Using reasonable care
  - iii) In accordance with the Society's instructions (if provided)
- The camper/hirer must not engage in any activity at the site during the hire period which may bring the reputation of the Esk Show Society into disrepute.
- The camper/hirer must not engage in any activity at the site during the hire period which may be or become offensive, dangerous, give rise to undue noise or smell or which in the opinion of the Esk Show Society may cause annoyance, offence or cause damage to the public. Persons engaging in such behaviour will be requested to leave immediately and shall forfeit all fees payable to the Esk Show Society.
- The camper/hirer must vacate the site by the hire end time. If the camper/hirer fail to do so the Esk Show Society may seek costs against the camper/hirer.
- If the camper/hirer fails to comply with any conditions during the hire period then the Esk Show Society may take immediately and without notice possession of the site and remove any goods from the site. Any goods removed in this way which remain in the Society's possession after a period of 30 days will be treated as abandoned and such goods will become the property of the Esk Show Society.
- All vehicles and trailers entering the site must have current vehicle registration.
- The camper / hirer indemnifies the Esk Show Society (including its members, agents and employees) against all claims, demands, actions, costs (including legal costs), charges, expenses, damages, loss or other liability arising out of or in connection with the camping/hire agreement.
- The camper/hirer must immediately notify the Esk Show Society of any accident or other incident related to camping / hire of the site at the Esk Show grounds.
- A maximum of 2 pets per camping/ hire site are permissible. All dogs must be kept on a leash at all times and all droppings are to be wrapped and placed in a bin. Pets are not permitted in the amenities block or where food/alcohol is being served, or in general concert area.
- No campfires are permitted on the Esk Showground.
